Adapun Tuntutan kami Agenda Nasional dan Daerah, yang Mendukung Langkah Presiden Prabowo Melawan Koruptor sebagai berikut :

Nasional :

1. Tangkap Hasto Tersangka Suap Kasus Harun Masiku.
2. Buka Kembali Kasus E-KTP.


Isu Daerah :

1. Mendesak KPK untuk melakukan Supervisi di Polda NTB atas Case Pembebasan Tanah Jalan By Pass Senayan Lamusung di Kab. Sumbawa Barat yang dilakukan oleh Bupati Sumbawa Barat W. Musyafirin.
2. Mendesak KPK untuk mengaudit Dana Korupsi 1 Triliun atau 1000 Miliar di APBD Perubahan Kab. SUMBAWA BARAT NTB yang digunakan interval waktu 4 Bulan (Agustus - Desember 2024) oleh Bupati Sumbawa Barat W. Musyafirin.
3. Mendesak KPK mengaudit CSR 900 M PT. Amman Mineral Nusa Tenggara dalam 10 Tahun Terakhir yang jadi Bancakan Anggota DPR RI Dapil NTB, Gubernur NTB dan Bupati Sumbawa Barat W. Musyafirin, dan Kasus Bandara Sekongkang Sumbawa Barat NTB.

Hundreds of residents of West Sumbawa, West Nusa Tenggara (NTB), under the Taliwang Youth Front Alliance together with the Jakarta Dynamics Forum (FDJ), will hold protests at the Corruption Eradication Commission (KPK) building, Jl. Kuningan Persada, South Jakarta and State Palace, Jl. Medan Merdeka Utara, Central Jakarta on Monday 13 January from 0900hrs to demand that the KPK arrest former politician Harun Masiku over a corruption case. The civil alliances also urge President Prabowo Subianto to re-evaluate a number of legal cases handled by the KPK and the NTB Regional Police.

BACKGROUND

Harun Masiku, previously a member of the Indonesian Democratic Party of Struggle (PDI-P), is accused of bribing former General Election Commission (KPU) Commissioner Wahyu Setiawan to secure a legislative seat. The KPK recently intensified its investigation, naming PDI-P Secretary-General Hasto Kristiyanto a suspect and imposing travel bans on him and former Law and Human Rights Minister Yasonna H. Laoly. Previously, on 23 December 2024, a demonstration outside the KPK building escalated into vandalism and stone-hurling, leading to clashes with security forces.

SECURITY MEASURES

Heightened security measures, including cordons and roadblocks, will be imposed at the KPK building, State Palace, and any areas where protests materialise. Demonstrators will be allowed to stage the action no further from the area of the Arjuna Wiwaha Horse Statue. Expect traffic disruptions on Jl. M.I. Ridwan Rais, Jl. MH. Thamrin, Jl. Majapahit, Jl. Ir. H. Juanda, Jl. Abdul Muis in Central Jakarta and Jl. HR. Rasuna Said in South Jakarta. Clashes between protesters and security forces are possible.

Traffic diversions and road closures will be implemented on a situational basis. The traffic diversions around the State Palace are as follows:

1. Traffic on Jl. MH. Thamrin heading towards Jl. Medan Merdeka Barat will be diverted to Jl. Budi Kemuliaan or Jl. Medan Merdeka Selatan
2. Traffic from Tugu Tani towards Jl. Medan Merdeka Selatan will be diverted to Jl. Perwira
3. Vehicles coming from Jl. Hayam Wuruk towards Jl. Majapahit will have to make a detour through Jl. Juanda or Jl. Suryopranoto
4. Traffic passing through Jl. Abdul Muis towards Jl. Gajah Mada will be directed to Jl. Tanah Abang Satu



PEGASUS ADVICE

- Exercise caution when passing through the vicinities of the Arjuna Wiwaha Horse Statue and State Palace in Central Jakarta; and KPK building in South Jakarta on Monday 13 January.
- Anticipate robust security and travel disruptions near the protest locations.
- Depart the area at the first sign of any security disturbance.
- Plot bypass routes as roads in the surrounding areas will be subject to closures and/or diversions, with little or no notice.
- Follow all security personnel instructions.
- Stay current with media coverage of local events, be aware of your surroundings, and practise personal security awareness at all times.
- Bear in mind that terrorists may use the situation to launch attacks at anytime and anywhere.
- Be advised that foreigners who join protests in Indonesia may be arrested and/or deported.
